- 2. BBPGEM shall provide space for VENDOR, to provide services or sell items at the Alexander Park 300 ATLANTA ST MCDONOUGH, GA 30253.*
- 3. The VENDOR agrees to operate in accordance with regulations set forth in the Georgia State Health Codes and he/she must comply with health and safety standards, where applicable.*
- 4. VENDOR space assignment will be made solely at the discretion of BBPGEM, with every effort made to honor all requests based on sponsorship levels first.*
- 5 Set up times for VENDORS is 10:00 am to 11:30 am on the day of the event. VENDORS will not be allowed to set up after the event start time. The vendor will forfeit their space and payment, if they try.*
- 6. VENDORS are prohibited from selling or possessing alcohol at the event.*
- 7. BBPGEM reserves the right to limit VENDOR'S vehicular access to the event area, as well as to disallow any VENDOR tent/structure that does not meet the City of McDonough standards.*
- 8. BBPGEM shall have the right to review and qualify the product line.*
- 9. The VENDOR will not sell or donate space in its booth or site for advertising and/or promotion to any third party.*
- 10. The VENDOR is responsible for paying all applicable federal, state, and local taxes.*
- 11. VENDOR agrees to pay all fines/penalties levied to VENDOR and to reimburse BBPGEM or any fines/penalties levied to BBPGEM a result of VENDOR'S noncompliance with any Federal, state, or local laws.*
- 12. VENDORS are responsible for any damage they may cause while participating in the day's events.*
- 13. All applicable permits are the sole responsibility of the VENDOR.*
- 14. Booth space fees are NOT REFUNDABLE for any reason (also to include inclement weather).*
- 15. VENDORS must provide their own tents, electricity, grills, tables, chairs, power cord, trash containers etc.*
- 16. Vendors will clean-up all trash that they or their customers are responsible for. Vendors who leave trash for BBPGEM staff to clean up will be fined \$150.00, payable to BBPGEM. before departure.*
- 17. BBPGEM reserves the right to reschedule or delay the event and or restrict access to certain areas in the event of an act of God (inclement weather or otherwise).*
- 18. VENDOR shall remain independent contractors, and nothing contained herein or done pursuant hereto shall be construed to create any relationship or principal and agent or employer and employee between BBPGEM and the VENDOR to make them joint ventures.*
